Snyder-Robinson Syndrome Patient Registry and Natural History Study (ongoing): This IRB-approved study gathers medical data from SRS patients to help researchers to understand SRS and to develop treatments for SRS. This includes salary paid to our Director of Research and related expenses (i.e., payroll taxes and payroll service).

Education/Website: We maintain a website to share information about SRS, including information for health care providers. Our website may be found at www.snyder-robinson.org. This includes an allocation of salary paid to our Director of Membership and related expenses. We also incurred \$50 of membership fees paid to The National Organization for Rare Disorders (NORD), which helps us educate interested stakeholders about SRS.

Conferences/Meetings: We participate in relevant scientific conferences, including the Gordon Polyamine Conference, where the role of polyamines and polyamine-associated pathways are discussed. Travel expenses for SRS meetings with researchers are also included in this category. This also includes an allocation of salary paid to our Director of Membership and related expenses.
